

COOKIES

We may use "cookies", "web beacons" and other similar technologies to collect information related to the operation of RELOCATO and our advertising. Our partners and outsourced service providers may also use cookies. A cookie is a computer file that serves as your computer's identification card to distinguish your browser from others, which allows us to provide you with a better service. However, please note that rejecting or deleting cookies may disable or interfere with RELOCATO functions and third-party services offered on the www.relocato.pro website or other websites you visit. We recommend that you leave cookies enabled so that we can offer you the best experience on our websites.

Interest-based advertising
